## FUNCTIONS OF THE EXECITUVE COMMITTEE AND OFFICE BEARERS

#### 1. PRESIDENT:

#### 5. TREASURER:

### OFFICE BEARERS :

They are responsible to attend to such activities of the Society, which the Executive Committee entrusts to them.

#### 7. QUORUM:

Halt of the total members for General Body meeting and 1/4 for Executive Committee meeting.

The funds shall be spent only for the attachment of the objects of the Society and no portion there of shall be paid to transerred directly or indirectly to any of the members through any means. Bank account will be opened and the account is operated jointly by the President and Gerural Secretary. (S. Pranitha)

#### 9. AMENDMENTS:

No amendment or alteration shall be made in the purpose of the Association unless it is voted by 2/3 of its members present at a special meeting convened to the purpose and confirmed by 2/3 of the members present and at a second special meeting.

In case the Society has to be wound up the properly and funds of the Society that remain after discharging the liabilities, if any, shall be transferred or paid to some other institutes with similar aims and objects.






